Personal data that we process

Bamsae Korean processes your personal data because you use our services and/or because you provide them to us yourself. Below you will find an overview of the personal data that we process:

- First and last name

- Date of birth

- Address details

- Email address

- Other personal data that you actively provide, for example by creating a profile on this website, in correspondence and by telephone

- Data about your activities on our website

- Data about your surfing behaviour across different websites (for example because this company is part of an advertising network)

- Bank account number

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years of age. Unless they have permission from parents or guardians. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. If you are convinced that we have collected personal data about a minor without this consent, please contact us at mail and we will delete this information.

For what purpose and on what basis do we process personal data

Bamsae Korean processes your personal data for the following purposes:

- Processing your payment

- Sending our newsletter and/or advertising brochure

- To be able to call or email you if this is necessary to be able to perform our services

- To inform you about changes to our services and products

- To offer you the opportunity to create an account

- To deliver goods and services to you

- Bamsae Korean analyses your behaviour on the website in order to improve the website and to tailor the range of products and services to your preferences.

#### Automated decision-making

Bamsae Korean [does / does not] make decisions based on automated processing on matters that can have (significant) consequences for people. This concerns decisions that are made by computer programs or systems, without a human being (for example an employee of Bamsae Korean) involved. #### How long we store personal data

#### Cookies, or similar techniques, that we use

Bamsae Korean uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Bamsae Korean uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work properly and to optimize it. In addition, we place cookies that track your surfing

behavior so that we can offer customized content and advertisements. When you first visited our website, we already informed you about these cookies and asked for permission to place them. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously stored via the settings of your browser. #### View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent for data processing or to object to the processing of your personal data by Bamsae Korean and you have the right to data portability. This means that you can submit a request to us to send the personal data that we have about you in a computer file to you or another organization named by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to mail To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. In this copy, black out your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN). This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks. Bamsae Korean would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
